4. **Members declarations of interest and Register of Interests**

Councillor Calvert declared an interest in item 10 (Village Hall) and Councillor Lamb declared an interest in item 10 (Village Hall) and item 11 (Millennium Path). Councillor Snowden an interest in item 15 Any Other Business Planning 21/01856/PLF Agricultural Building and Land.

Councillor Calvert declared a non-pecuniary interest in item 10 (Village Hall) and Councillor Lamb declared a non-pecuniary interest in item 10 (Village Hall) and item 11 (Millennium Path). Councillor Snowden declared a pecuniary interest in item 15 (Any Other Business Planning 21/01856/PLF Agricultural Building and Land).

5. **Village Pond**

The report written by Barbara Clark was circulated. It was agreed to revisit at the end of October and arrange maintenance in Nov-Jan.

6. **Minutes**

The minutes of the meetings held on 4th May 2021 were read and proposed by Councillor Lamb and seconded by Councillor Hill.

8. **ERYC matters and correspondence**

i. **Anti Social Behaviour 6 months stats and Safe and Sound Grant**

It was noted that Lund was showing as zero on all statistics. Details of the Safe and Sound Grant will be published in the Forge and mentioned on the Facebook page.

ii. **Draft Local Plan Update Consultations**

Two e mails were circulated with regard to the Local Plan and local consultations. No further action required.

iii. **Briefing on Bus Strategy**

It was agreed that the strategy relates more to core services and is debatable whether we would qualify for improvements. It was agreed that no further action is required.

iv. **Heywoods Tree Planting Fund**

Whilst a great initiative this suggests funding for woodland and new clusters of trees which isn't really appropriate for the village. Other initiatives for single trees may be considered.

v. **2022 Birthday Honours**

Agreed to consider and bring back to the next meeting.

vi. **Police and Crime Prevention Survey**

Circulated to all to complete. Joanna Johnston has completed highlighting the traffic issues on North Road.

vii. **National Highways and Transport Network Survey**

It was agreed that Joanna Johnston should complete on behalf of the Parish Council and mention the junction at West End where the hedges were not trimmed.

9. Purchase of Telephone Box

Cllr Hill confirmed that he had sought legal advice on the contract. The advice was to consider who owns the land (assume ERYC), the contract is silent on whether it can be moved, In paying £1, BT have protected themselves and passed obligations to council with all maintenance on the parish council. It is a listed building so maintenance should be considered.

All Parish Councillors were in favour of buying it but before proceeding it was agreed that the public liability insurance would be checked, whether it was covered and if not how much more would be charged.

10. Village Hall Update

David Latus confirmed that the outside patio was being redone and toughened glass panels erected subject to committee approval.

11. Millennium Permissive Path

David Latus highlighted that the briars by the bridge needs to be cut.

12. Website Update

Joanna Johnston confirmed that James Tingay had updated the website with all the items for the Audit, all agendas and minutes.

Cllr Lamb mentioned that Lund Link were considering paying a professional to do the magazine each quarter and asked if the Parish Council would be interested in supporting. It was unanimously agreed that this would be considered.

It was agreed that a gift would be procured as a thank you for completing the internal audit.

15. Any Other Business

- i. Cllr Burns raised an issue which had been discussed with her about the possibility of erecting a sign from The British Horse Society on Lockington Road about slowing for horses. It was agreed that the sign was large and we would be better pursuing again the issue of slower speed limits in the village, perhaps a 30 sign with a 20 advisory speed. Cllr Burns agreed to write an article in Lund Link and Joanna Johnston agreed to pursue the speed issue with ERYC again.
Cllr Snowden raised the issue of parking in the village around the green. It was agreed that there were not many alternatives but that a slower speed limit would help.
- ii. Cllr Calvert highlighted the recent communications in the press about whether East Yorkshire would achieve an Area of Natural Beauty (AONB) status. There will be consultation and there is some debate whether we will fall in the designated area.
