2. **ERYC Councillors**

Cllr P Greenwood advised us that planning for a petrol station at Killingwoldgraves Lane Bishop Burton has been turned down again.

Cllr Prescott asked for Cllr Greenwood to feed back that the Planning website is poor, is regularly out of action and not very user friendly.

Cllr Greenwood explained that there was to be a Group Meeting at the end of August when a County deal was to be discussed amongst other issues.

7. **ERYC matters and correspondence**

i. **2022 Birthday Honours**

The e mail from Jordan Goucher Victim Support Fund Raising Manager was circulated. Whilst it was agreed that this was a worthy cause a donation was not approved.

8. **Traffic Issues**

Joanna Johnston confirmed that she had reported the traffic issues raised at the last meeting. Two reports have been submitted. One about the speeding down Lockington Road and the other about speeding in the village and parking on the corner going out of the village towards the pond. The reports are Ref 1918882 and Ref 1918944. No further contact has been received since filing the reports. Cllr Greenwood explained that Paul Tripp is the person in charge at ERYC and agreed to pursue on our behalf. 20 mph speed limit would be advisable in the village.

9. **Purchase of Telephone Box**

Joanna Johnston confirmed that the public liability insurance has been checked and is covered on page 5 of the policy under street furniture. (Automatically covered up to £30k without further charge). Registration forms have been requested.

10. Village Hall Update

David Latus confirmed that an event will be held on 5th September where funds will be used to subsidise proceedings. All residents of the village are welcome. Tickets are now on sale. It is an ideal opportunity to welcome new residents into the village.

David Latus explained that the Grillo is no longer adequate for the grass at the village hall. The grass is being cut by a number of volunteers using their own equipment which is not adequate. It was agreed that the Parish Council would purchase a better machine, part exchanging the old machine. The Village Hall would make a donation of the cost excluding VAT. Jonathan Walker and David Latus would check availability and cost. Proposed by Cllr Ward and seconded by Cllr Burns.

David Latus thanked Cllr Prescott for cutting the path. It was agreed to put the agreement to continue to use the path on the agenda for the next meeting.
