2. ERYC Councillors

Mr Andrew Waters raised the issue of the emptying of the brown bin at the church again. Given ERYC now class the church as Commercial Premises and therefore the waste is business waste. There is not much the Parish Council or the ERYC Councillors can do. It was agreed not to write to ERYC but that Cllr Prescott and others would remove the leaves/garden refuse if this became an issue.

Cllr Beaumont raised the informal network meetings to be held by ERYC to hear Parish Council issues and the letter from Newbald Parish Council. Some Parish Councils don't have the same issues as us much depends upon the population of the Parish. See below 7ii and ANO Business.

Cllr Prescott raised that he intended to prune a hawthorn bush on the verge opposite Mr and Mrs Kerwin's house on Cherry Garth. It was dangerous and he had been contacted by a resident.

The subject of the issues with speeding and road noise on B1248 were discussed again. Cllr Greenwood had been to the village and commented on the dangerous bend at the end of North Road and how difficult it was to get out due to speeding cars and motorbikes. She suggested that we should write again to Paul Tripp copy Paul Belotti with photographs explaining that the Ward Councillors had experienced the issues.

7. ERYC matters and correspondence

i. Dog Poo Bins

ii. Town and Parish Council Charter

It was agreed that the Charter will be adopted by Lund. The dates of the Network Meetings were circulated - Wednesday 16 March at 2pm - 3.30pm and Thursday 17 March at 7pm - 8.30pm. Cllr K Calvert agreed to attend the meeting on afternoon 16th March and Joanna Johnston agreed to circulated details of the meetings to all should anyone else wish to attend. 8. Vacancy for a Parish Councillor

Joanna Johnston confirmed that the statutory notice had been posted and we have now received the go ahead from ERYC to coopt a councillor onto the council. Two expressions of interest have been received. One from Caron Wright on North Road and one from Simon Gray Queensmead. It was agreed proposed by Cllr Ward and seconded by Cllr Calvert on this occasion to coopt Caron onto the Councillor but consider Simon should a further vacancy arise. Joanna Johnston to arrange for all the necessary documentation to be completed.

9. Queens Platinum Jubilee

i. Update from Cllr Lamb

explained that he had arranged a meeting on 10th February at The Wellington to discuss what can be arranged.

ii. Update Grant

Grant up to £500 available from ERYC. Joanna Johnston has submitted costings and tangible spend. More likely to get it if matched by Parish Council/Village Hall/Fund Raising. Supply final invoices after event. To discuss at the next meeting how Parish Council support

iii. Road Closures

ERYC have offered to close roads if we need it. To discuss at next meeting if necessary. Seems unlikely.

10. <u>Defibrillator Maintenance</u>

Cllr Astbury explained that the defibrillator was acquired in 2016 through a charity in Beverley. It is the property of The Parish Council. It was installed in the Forge with permission from the Church. The Wellington Inn pay for the electricity supply. There is nothing in the manuals about maintenance, it is checked every 28 days by Cllr Astbury. It recommends the batteries are replaced every 5-6 years these were replaced last year. Cllr Astbury holds a spare set of pads should they be required. Every 4-5 weeks Cllr Astbury receives an e mail to confirm that it has been checked and is ok.

Whilst the ambulance service give instructions and the code to get into the box it is recommended that familiarisation training is given.

Joanna Johnston has arranged a session on 12th April at 7pm at Village Hall for 1hour 30 mins which will be undertaken by First Aid Box Training Solutions Driffield. This is free of charge but a donation is welcomed to their annual charity. Cllr Astbury will circulate details to the village and Joanna Johnston will arrange to be available on the night as Cllr Astbury is on holiday.

11. Purchase of Telephone Box

Cllr Astbury reported back to Parish Council. He made a number of observations:

Discuss what we want to do with it

Buying structure not the land

Power supply to it – give notice to BT to maintain the power supply

Still comfortable that we buy it given we don't know what might happen in the future

Cllr Lamb proposed and Cllr Watts seconded that we go ahead. Cllr Prescott to sign the contract.
